**Meeting Started at 8:07 a.m.**

**Call to Order – Roll Call**

The President called the meeting to order with the following members present. Mrs. Downs, Dr. Edinger, Mr. Schoenlein and Mr. Van Hoozen. Mrs. Hovland was absent for the entire meeting.

**FY10-01-007 – Adopt the Proposed Agenda**

Mrs. Downs moved, seconded by Dr. Edinger the Board adopt the proposed agenda. The President called for the vote. Voting yes; Mrs. Downs, Dr. Edinger, Mr. Schoenlein and Mr. Van Hoozen. Motion carried.

1. Board Meeting Protocol – Mrs. Downs

2. Graduation Requirements – Mr. Schoenlein  
Mr. Schoenlein asked how the district was informing secondary students and parents about courses of study available at Perrysburg Schools. Are we doing that soon enough so students/parents can make informed decisions regarding college/career paths as they proceed through the Jr. High and High School. What is being done at each grade level? Mr. Hosler addressed the issue but indicated that he would discuss this further with Kadee Anstadt and Kevin Gorman.
3. Letter of Appreciation – Mrs. Downs  
Mrs. Downs suggested that the Board send a letter of appreciation to Senator Mark Wagner for his recent support of schools in the recent tax cut deliberations with Governor Ted Stickland. Senator Wagner crossed party lines to support the cancellation of a tax cut scheduled for 2010. School districts across the state would have suffered significantly with projected ten (10%) and fifteen (15%) percent tax cuts that would have been inevitable with the loss in state revenue. Senator Wagner should be commended for placing the well being of students across the state ahead of political agendas.

It was also suggested that a letter of appreciation be sent to Representative Randy Gardner for his efforts against unfunded mandates facing school districts in Northwest Ohio.

Mr. Hosler indicated that he would be happy to do that.
