
In 2012, this operational levy passed:

51% YES and 49% NO Decided by just 459 votes of 15,799 cast.

What happens if the levy fails?

Essay...

- A failed levy would result in a loss in revenue of \$12.9 million effective January 1, 2017.
- The district will begin to make some immediate cuts as early as December 2016 and proceed to implement drastic cuts for the 2017-2018 school year.
- This would mean a significant change in what is now being provided.
