LPDC Approved Public SchoolWORKS Trainings

Per the PEA Collective Bargaining Agreement August 1, 2024 through July 31, 2027, the LPDC will determine and publish the mandated trainings for which members may receive contact hours. To the extent these hours are approved by LPDC, these approved trainings will be credited to members' contact hours. Members may apply for contact hours for all additional mandated trainings.

The CEU is a nationally recognized system of recording and recognizing participation in noncredit professional education courses, programs and other activities. The CEU records the extent of an individual's participation in noncredit continuing education activities, and should not be confused with performance and/or activities that are reflective of everyday practice and responsibilities. Activities proposed for CEU credit must:

- Satisfy all aspects of the definition of the CEU.
- Clearly state the program's educational objectives.
- Be conducted by qualified instructional personnel and/or demonstrate that the activity is beyond an extension of everyday practice and responsibilities. Specify performance objectives before the program begins.
- Require registration and attendance details sufficient for a permanent record of individual participation.
- Be evaluated by procedures designed during the planning process to measure quality and effectiveness.
- Include procedures for establishing satisfactory completion by each participant.

Members are only allowed to receive contact hours for the same training one time per licensure cycle and are not able to receive additional contact hours for the same training from year to year. Members will be required to submit their request for credit hours in Frontline. Members are not able to receive credit for training hours before July 1, 2024.
