Community Service Seal

State Description

Complete a community service project aligned with the guidelines adopted by the student's local board of education or school governing authority.

Perrysburg Schools Seal Requirements

The student must complete a community service project (CSP) that meets the following requirements.

- Approval** The CSP must be approved by a project advisor (PA). The PA must be an educator in the school district or a community mentor approved by the Building Principal. No credit for service will be recorded without the PA's signature of approval.
- Hours** The Student must complete and record at least 50 hours of work dedicated to the project. All hours claimed for the project must be directly related to the project. A student may not claim an accumulation of unrelated service hours. Service or engagement hours must take place outside of the school day.
- Impact** The project must benefit a community organization or a school. No family members may be the recipients or supervisors of service.
- Volunteerism** The project cannot be for pay.

These requirements may be replaced with those of the [Social Science and Civic Engagement Honors Diploma defined by the Ohio Department of Education](#).

Seal Verification

The following documents will verify the achievement of the seal. All forms must be submitted to the high school counselor. The counselor will verify seal achievement and inform the building principal and the teaching and learning department.

- Project Proposal** [This form](#) is completed by the student in collaboration with a PA and signed by both student and PA.
- Project Report** [This form](#) is completed by the student in collaboration with a PA and signed by both student and PA. This includes a log of hours.

State Description

Complete a community service project aligned with the guidelines adopted by the student's local board of education or school governing authority.

Perrysburg Schools Seal Requirements

The student must complete a community service project (CSP) that meets the following requirements.

Approval

The CSP must be approved by a school project advisor (PA) or outside school approved organizations. No credit for service will be recorded without the PA's signature of approval.

If a student is taking a PHS class that incorporates community service outside of the school day, the CSP is integrated into the class.

Hours

The Student must complete and record at least 50 hours of volunteer community service work. Service hours must take place outside of the school day.

NOTE: If a student joins PHS as a Senior, 12.5 hours is required for volunteer work. If a student joins PHS as a Junior, 25 hours is required for volunteer work. If a student joins PHS as a Sophomore, 37.5 hours is required for volunteer work.

Impact

The project must benefit a community organization or a school. No family members may be the recipients or supervisors of service.

Volunteerism The project cannot be for pay.

These requirements may be replaced with those of the [Social Science and Civic Engagement Honors Diploma defined by the Ohio Department of Education](#).

Seal Verification

The student must document all community service hours in a log and submit it to their PHS counselor. If a community service seal is part of a PHS class where service hours occur outside of the school day or as part of a PHS Club activity, the PHS teacher and/or PHS Club Advisor will maintain documentation as a part of the class or club experience to aid in volunteer hour tracking. Fine and Performing Arts Seal

State Description

Demonstrate skill in the fine or performing arts according to an evaluation aligned with guidelines adopted by the student's local board of education or school governing authority.

Seal Requirements

The student must complete a minimum number of courses, participate in fine arts extracurricular activities, and receive an endorsement of fine arts proficiency from a Perrysburg educator.

Courses The student must earn no fewer than 3 full credits in fine or performing arts courses. These courses include the areas of art, theater, and music. For these purposes, full participation in a school theater production equates to 0.5 fine arts credits.

Activities The student must participate in 1 fine arts extracurricular activity with full participation, as determined by the teacher or other adult in charge.

These requirements may be replaced with those of the [Arts Honors Diploma defined by the Ohio Department of Education](#).

Seal Verification

The following documents will verify the achievement of the seal. All forms must be submitted to the high school guidance counselor, who will verify seal achievement and inform the building principal and the teaching and learning department.

Completion Verification [This form](#) will be completed by the counselor, extracurricular teacher or adult in charge, and a fine arts educator from Perrysburg Exempted Village Schools. The form will attest to the completion of the three requirements stated above.

Fine and Performing Arts Seal

State Description

Demonstrate skill in the fine or performing arts according to an evaluation aligned with guidelines adopted by the student's local board of education or school governing authority.

Seal Requirements

The student must complete a minimum number of courses, participate in fine arts extracurricular activities, and receive an endorsement of fine arts proficiency from a Perrysburg educator.

Course / Activities

The student must earn no fewer than 3 full HS credits in fine or performing arts courses. These courses include the areas of art, theater, fine arts and music. Students may be required to be involved in fine arts extracurricular activity while enrolled within these courses, as deemed necessary and appropriate by the teacher of record.

These requirements may be replaced with those of the [Arts Honors Diploma defined by the Ohio Department of Education](#).

Seal Verification

PowerSchool tracks this and no form is needed for verification unless the student is completing the [Fine Arts Honors Diploma packet](#).

Student Engagement Seal

State Description

Participate in extracurricular activities such as athletics, clubs, or student government to a meaningful extent, as determined by guidelines adopted by the student's local board of education or school governing authority.

Seal Requirements

The student must meet any one of the following participation requirements. Each requirement defines *participation* as full and active status for an entire year's duration of the activity.

- Option 1** The student demonstrates two years of participation in one activity
- Option 2** The student demonstrates three years of participation in various activities.
- Option 3** The student demonstrates one year of well-rounded activity participation, including at least three of the following types: athletics, fine arts, academic competitions, or student clubs or organizations.

Seal Verification

The following document will verify the achievement of the seal. All forms must be submitted to the high school guidance counselor, who will verify seal achievement and inform the building principal and the teaching and learning department.

Engagement Verification [This form](#) carries signatures and descriptions verifying and explaining the student's participation.

Student Engagement Seal

State Description

Participate in extracurricular activities such as athletics, clubs, or student government to a meaningful extent, as determined by guidelines adopted by the student's local board of education or school governing authority.

Seal Requirements

The student must meet any one of the following participation requirements. Each requirement defines *participation* as full and active status for the duration of one entire cycle of the activity.

Option 1

The student completes two seasons of participation in a PHS Sport, PHS Show Choir or PHS Band (a student will also meet the requirements for a physical education waiver in satisfying this option).

Option 2

The student demonstrates participation in two clubs or activities while enrolled at PHS.

Seal Verification

PowerSchool tracks this and no form is needed for verification.
